[Orange County Eviction Diversion Program](#)- In an effort to help curb the onslaught of possible evictions due to the COVID-19 pandemic, the Orange County Board of County Commissioners created the Orange County COVID-19 Eviction Diversion Program. The [\\$20 million program is funded by the Federal CARES Act monies](#) allotted locally and the Florida Housing CARES Act – Coronavirus Relief Funds.

[City of Orlando Cares](#) - Through a contractual partnership agreement with the City of Orlando, Heart of Florida United Way (HFUW) will manage the CARES rent assistance program to include screening applicants to verify Orlando city limit residency, collecting the full application and required documents, and issuing rent assistance payments directly to landlords/property managers.

The City of Orlando is funding this program with \$1,532,608 in Coronavirus Relief Funds (CRF) and anticipates being able to assist an estimated 300 households with the available funding.

The City of Orlando CARES Rent Assistance Program is limited to residents in Orlando city limits who have lost employment due to COVID-19/Coronavirus. Under this partnership, HFUW will provide case management that will allow eligible households to receive up to \$10,000 in rent assistance per household.

Los nuevos criterios incluyen a cualquier persona con síntomas de COVID-19 independientemente de su edad, todos los socorristas y

trabajadores de la salud y cualquier persona que haya tenido contacto cercano con alguien que haya dado positivo a COVID-19. La cantidad de pruebas administradas fueron aumentadas de 250 a 400 pruebas por día. El centro de pruebas está ubicado en 9400 Universal Blvd., Orlando, FL 32819.

Additionally, the [Primary Care Access Network](#) in Orange County may be able to assist underinsured and uninsured residents with access, quality, and coordination of health care services.

**SNAP & Medicaid** -As directed by Governor DeSantis, the maximum monthly allotment of Supplemental Nutritional Assistance Program (SNAP) benefits has been temporarily increased based on household size for April. Six-month recertification extensions have been granted to families scheduled to recertify in April or May for SNAP, TANF, and Medicaid benefits. No current recipients of Medicaid will lose benefits during the State of Emergency. For more on these programs, visit [MyACCESS](#).
